Binnacle Training is approved as a Pre-qualified Supplier (PQS) for the VETIS funded qualification: **Certificate II in Sport and Recreation (SIS20115).**The VET investment budget will provide funding for eligible students to complete one VETIS qualification listed on the Queensland Training Subsidies List while attending secondary school (in Years 10, 11 and 12). Qualifications are primarily at Certificate I and II level and are those that have been identified by industry as leading to employment.
