An invoice will be issued upon submission of the Binnacle First Aid ‘Status Report’ for \$40.00 per ‘Fee For Service’ participant that has completed the Binnacle First Aid course.

** Vocational Education and Training in Schools (VETiS) Initiative, funded by the Queensland Government. The VET investment budget will provide funding for eligible students to complete one VETiS qualification listed on the Queensland Training Subsidies List while attending secondary school (in Years 10, 11 and 12). Qualifications are primarily at Certificate I and II level and are those that have been identified by industry as leading to employment.*
