Dual Qualification Program: 2020 Certificate III in Fitness + Certificate II in Sport and Recreation (3-Year)	
<b>Qualifications</b>	SIS20115 Certificate II in Sport and Recreation → VETiS* funding eligible qualification SIS30315 Certificate III in Fitness
<b>Cost</b>	<p><b>Participant Fee:</b> \$290.00 per student (\$210.00 Cert II Sport and Recreation + \$80.00 Certificate III Fitness Gap Fee) + \$40.00 First Aid</p> <p><b>NOTE:</b></p> <ul style="list-style-type: none"><li>Students that exit at the year of the first year will only incur the \$210.00 Cert II Sport and Recreation participant fee.</li><li>Students that enter the program in 'Year 2' will incur the \$290.00 Cert III Fitness participant fee.</li></ul> <p><b>Program Fee</b> (note these figures are inclusive of GST):</p> <ul style="list-style-type: none"><li>1 x Certificate III Program (e.g. Fitness) = \$1,210.00</li><li>2 x Certificate III Programs (e.g. Fitness, Sport) = \$1,485.00</li><li>3 x Certificate III Programs (i.e. Business, Fitness, Sport) = \$1,760.00</li></ul>
<b>Enrolment Points</b>	<p><b>Certificate II in Sport and Recreation</b></p> <ul style="list-style-type: none"><li>Term 1 = Initial Enrolment</li><li>Term 2 = Official Enrolment</li></ul> <p><b>Certificate III in Fitness</b></p> <ul style="list-style-type: none"><li>Term 5 = Initial Enrolment (new students only)</li><li>Term 6 = Official Enrolment</li></ul>

\* Vocational Education and Training in Schools (VETiS) Initiative, funded by the Queensland Government. Binnacle Training is approved as a Pre-qualified Supplier (PQS) for the VETiS funded qualification: **Certificate II in Sport and Recreation (SIS20115)**. The VET investment budget will provide funding for eligible students to complete one VETiS qualification listed on the Queensland Training Subsidies List while attending secondary school (in Years 10, 11 and 12). Qualifications are primarily at Certificate I and II level and are those that have been identified by industry as leading to employment.

<b>TERM 3</b>	<p><u>ADJUSTMENT INVOICE #1</u> – To be issued after the enrolment cut-off date (30 June 2020) for the Certificate II in Sport and Recreation and will include:</p> <ul style="list-style-type: none"><li>Certificate II in Sport and Recreation participant fee (\$210.00) per ‘Fee For Service’ participant (i.e. those students that have opted out [or are ineligible] of accessing their VETiS funding for the Binnacle Certificate II in Sport and Recreation entry qualification.</li></ul> <p>* Binnacle will waive the Certificate II in Sport and Recreation participant fee (\$210.00 pp) invoiced to the school for those students that have opted in (and are eligible) to access their VETiS funding for the Certificate II in Sport and Recreation with Binnacle.</p> <p><i>Please see a copy of the example invoice (over page) for details.</i></p>

If there is a credit balance on the adjustment invoice, this can be paid direct to the school’s nominated bank account or applied as a credit note against future invoices.</i></li></ul> <p><i>Please see a copy of the example invoice (over page) for details.</i></p>
