TERM 2	<p>Certificate II in Sport and Recreation → VETiS Funding Confirmations</p>
TERM 3	<p>ADJUSTMENT INVOICE #1 – To be issued after the enrolment cut-off date (30 June 2022) for the Dual Qualification Program and will include:</p> <ul style="list-style-type: none"> • Certificate II in Sport and Recreation participant fee (\$265.00) per 'Fee For Service' participant (i.e. those students that have opted out [or are ineligible] of accessing their VETiS funding for the Binnacle Certificate II in Sport and Recreation entry qualification). • Certificate III in Sport and Recreation Gap Fee (\$70.00) for each participant. <p>* Binnacle will waive the Certificate II in Sport and Recreation participant fee (\$265.00 pp) invoiced to the school for those students that have opted in (and are eligible) to access their VETiS funding for the Certificate II in Sport and Recreation with Binnacle.</p> <p><i>Please see a copy of the example invoice (over page) for details.</i></p>

ADJUSTMENT INVOICE #2 – This invoice will include the following:

- *For partner schools with one or more students accessing their VETiS funding with Binnacle for the Certificate II in Sport and Recreation: A credit for Binnacle’s Resource Fee Payable to the School will be applied (\$150.00* per completed VETiS participant). If there is a credit balance on the adjustment invoice, this can be paid direct to the school’s nominated bank account or applied as a credit note against future invoices.*

** For completed VETiS students who have had two or more units of competency reported as Credit Transfer, a pro rata allocation of Binnacle’s Resource Fee Payable to the School (\$150.00) will be applied based on the number of competencies in which revenue is received by Binnacle Training from the Queensland Government.*

An invoice will be issued upon submission of the Binnacle First Aid ‘Status Report’ for \$55.00 per ‘Fee For Service’ participant that has completed the Binnacle First Aid course.

** Vocational Education and Training in Schools (VETiS) Initiative, funded by the Queensland Government. Binnacle Training is approved as a Skills Assure Supplier (SAS) for the VETiS funded qualification: **Certificate II in Sport and Recreation (SIS20115)**. The VET investment budget will provide funding for eligible students to complete one VETiS qualification listed on the Queensland Training Subsidies List while attending secondary school (in Years 10, 11 and 12). Qualifications are primarily at Certificate I and II level and are those that have been identified by industry as leading to employment.*
