TERM 3	<p><u>ADJUSTMENT INVOICE</u> – To be issued after the enrolment cut-off date (30 June)* and will include:</p> <ul style="list-style-type: none"> Participant fee (\$265.00 pp) per 'Fee For Service' participant (i.e. those students not accessing their VETiS subsidy for SIS20115 Certificate II in Sport and Recreation with Binnacle Training). <p><i>Please see a copy of the example invoice (over page) for details.</i></p> <p>* Students that withdraw from the program after the enrolment cut-off (30 June) do incur the participant fee and will be issued (on request) a Statement of Attainment for any competencies successfully completed.</p> <p><i>Vocational Education and Training in Schools (VETiS) Initiative, funded by the Queensland Government. Binnacle Training is approved as a Skills Assure Supplier (SAS) for the VETiS funded qualification: Certificate II in Sport and Recreation (SIS20115). The VET investment budget will provide funding for eligible students to complete one VETiS qualification listed on the Queensland Training Subsidies List while attending secondary school (in Years 10, 11 and 12). Qualifications are primarily at Certificate I and II level and are those that have been identified by industry as leading to employment.</i></p>	

TERM 4	<p><u>FIRST AID INVOICE (IF APPLICABLE)</u></p> <p>This Certificate Program requires completion (as a separate course) of the nationally recognised First Aid Certificate: HLTAID011 Provide First Aid (which contains the embedded competency: HLTAID009 Provide cardiopulmonary resuscitation). HLTAID011 is available for eligible schools to deliver with Binnacle Training as a separate course (with additional School Physical Resource requirements). Otherwise HLTAID011 may, at your School's discretion, be undertaken with another RTO offering this unit of competency.</p> <p>For Schools who deliver First Aid with Binnacle Training:</p> <ul style="list-style-type: none"> An invoice will be issued upon completion for \$55.00 per student. Note, this fee is waived for students accessing their VETiS subsidy for the Certificate II in Sport and Recreation with Binnacle Training.
