TERM 3	REFUND POLICY The nature of Binnacle's invoicing process negates a school refund situation arising. Binnacle will only invoice for the minimum of 10 places prior to the enrolment cut-off (2-year courses = 30 June, in the year of course commencement). Per above, an adjustment invoice reflecting the balance of places after this date will then be issued – voiding any potential refund situation. Students that withdraw from the program after the enrolment cut-off (30 June) do incur the participant fee and will be issued (on request) a Statement of Attainment for any competencies successfully completed.
