

This document is to verify that you **DO NOT** hold a current Certificate IV in Training and Assessment (TAE) and have been enrolled in a Certificate IV in Training and Assessment course with a TAE RTO and are committed to completing it **by the end of Term 1** (1 April 2024).

This 'Notice of Intent' is required to be completed and uploaded to your Binnacle Profile in the TAE 'Evidence of qualification' section prior to enrolling students into a class in Term 1, 2024.

This 'Notice of Intent' will expire on 1 April 2024. If you have not completed your TAE40122 or TAE40116 by this date, the official enrolment of students with Binnacle Training CAN NOT proceed as scheduled (commencement of Term 2 assessment). This will result in:

- a. blocks to students accessing their assessment as well as the ability to mark assessment; or
- b. your class being transferred to an alternative (qualified) deliverer.

PHASE 1 OF 2: Obtain the 'Work Skill Instructor' Skill Set (or an alternative Skill Set listed below) - to commence delivery - Due 1 February 2024.

To commence delivery **without** a TAE40122 or TAE40116, a 'Work Skill Instructor' Skill Set (or an alternative Skill Set - see below) is required (as a priority) from a TAE RTO to allow you to be 'Working Under Supervision' and commence delivery of the Training Program whilst you are obtaining the full TAE qualification. PHASE 2 OF 2: Obtain a full TAE - Certificate IV in Training and Assessment (TAE40122 or TAE40116) (to continue to deliver) - Due 1 April 2024.

The Trainer MUST hold the Certificate IV in Training and Assessment (TAE40122, TAE40116 or TAE40110*) qualification by official enrolment (commencement of Assessment Term 2):

*If you hold the superseded TAE40110, two new core units must also be held:

- 1. TAEASS502 Design and develop assessment tools (or equivalent); and
- 2. TAELLN411 Address adult language, literacy, and numeracy (LLN) skills (or equivalent)

PHASE 1 - OBTAIN WORK SKILL INSTRUCTOR SKILL SET

BINNACLE ASSISTED PATHWAYS:

Work Skill Instructor Skill Set

As a matter of urgency for deliverers (who do not hold a full TAE40122 or TAE40116) to deliver VET under supervision we strongly advise to check with your TAE RTO to ensure you can obtain one of the following Skills Sets **first** as part of your full TAE40122:

- TAESS00028 Work Skill Instructor Skill Set
- TAESS00020 Workplace Trainer Skill Set
- TAESS00021 Facilitation Skill Set

A Skill Set is required to enable you to be 'Working Under Supervision' and continue to deliver any Binnacle Training Program beyond official Enrolment (commencement of assessment in Term 2).

Helpful Information

RTO's offering the 'NEW' TAE40122:

- No need for a separate enrolment into a Skill Set
- The units in these Skill Sets are part of the TAE40122, depending on the electives chosen by the TAE RTO:
 - O TAESS00028 Work Skill Instructor Skill Set
 - O TAESS00020 Workplace Trainer Skill Set
 - O TAESS00021 Facilitation Skill Set
- Advise the RTO you need to complete the Skill Set units first (those in the Skill Set list on page 1)
- Upon completion of the Skill Set, request a Statement of Attainment from the RTO to provide to Binnacle Training

Consider RPL:

 Most teachers would be able to provide evidence for some of the skills required to obtain a Skill Set and TAE and request a list of units that teachers are typically able to RPL. Also request an RPL Kit to evaluate what evidence is required to determine if this is an option for you.

PHASE 2 - OBTAIN THE FULL TAE QUALIFICATION

Certificate IV in Training and Assessment - Helpful Information

Any of the above three Skill Sets allows you to deliver Binnacle Training Programs via a 'Working Under Supervision' agreement (for a maximum of six months) while you are obtaining your full TAE. A Skill Set **IS REQUIRED** to enable Binnacle Training to place you under a 'Working Under Supervision' agreement.

Once you have obtained a Skill Set the next step is to issue a 'Working Under Supervisions' agreement.

Upon completion of your Full TAE please provide Binnacle Training with a copy (including transcript) of your full TAE Qualification. This will be verified and uploaded to remain in your Binnacle Profile.
